CONDITIONS OF PROBATION

It is the judgment of this Court that the Defendant is guilty of the crime(s) of: _____

On the _____ day of _____, 19____, the Court (suspended, reinstated) imposition of sentence for _____ (years) (months) and placed you on (supervised) (unsupervised) (intensive) probation under the charge and supervision of the Adult Probation Department of Yavapai County. You are advised that you were given probation on the following standard and special conditions of probation:

AS STANDARD CONDITIONS DEFENDANT SHALL:

1. Obey all laws.
2. Report in person monthly to your Adult Probation Officer or as otherwise directed.
3. Advise the Adult Probation Officer of your residential address and do not change your residence or leave the state of Arizona without prior approval.
4. Participate and cooperate fully in any program of counseling and/or assistance as directed by the Adult Probation Officer.
5. Avoid contact with, or use of, any illegal drugs. Submit to urinalysis, chemical or blood testing as required by a Probation Officer.
6. Be gainfully employed and/or enrolled as a student, unless excepted therefrom by the Probation Officer, and advise of any change in your status.
7. Not knowingly associate with any person whom you have reason to believe is violating the law, or has a criminal record, without prior approval of the Probation Officer.
8. Be subject to arrest by a Probation Officer and waive extradition for any probation revocation procedures pursuant to A. R. S. Sec. 13-901.
9. Not possess or have access to any deadly weapon or firearm without permission of your Adult Probation Officer.
10. Submit to search and seizure of your person or property at any time by any Probation Officer without benefit of a search warrant or probable cause.
11. Report to the Adult Probation Department immediately after this hearing and/or within 72 hours of release from any period of incarceration, imprisonment or residential treatment.
12. Speak with your Probation Officer within 72 hours of any Law Enforcement contact.
13. Abide by any other regulations as deemed appropriate by your Probation Officer.
